The COVID-19 Landscape

Despite the myriad of challenges brought upon by the continuation of the COVID-19 pandemic into FY21, MMF grant-funded agencies demonstrated resolve and resilience as they navigated the unprecedented service environment. As public health mandates began to ease and vaccines were made available, agency representatives had to develop new and innovative ways to continue meeting the needs of the community, even as the pandemic surged. Some identified trends included:

- Uncertainty loomed and public health guidelines changed often, making decisions such as returning to in-person services more difficult
- Many agencies continued to offer virtual or hybrid platforms to deliver services when possible,
 and when preferred by clients to decrease barriers of travel, childcare, and COVID-19 risk
- Staffing was a consistent and major challenge for agencies this grant period, including declines in volunteerism globally
- Providers developed deep relationships with clients, as well as other community partners
- Most agencies saw great increase in demand for services, concurrent with staffing disruptions
- Social isolation from traditional support networks impacted people across all focus areas, which
 had a destabilizing effect on households and mental health for populations that had not
 previously sought services

As MMF continues to learn about the ever-evolving challenges and opportunities created by our COVID-19 landscape, we rest assured that our grant-funded agencies and the communities they serve will remain steadfast in increasing stability and improving outcomes within our region.

Our Mission:

Theory of Change:

Through their unique ability to care for, engage and empower people to be active on their own behalf, nonprofit organizations are central to advancing the common good and serve as catalysts for positive, substantive change in conditions and systems that improve the quality of life and empower individuals and communities to advocate for themselves.

All Focus Areas

Drawing from our Mission and Theory of Change, the overall impact of MMF's grant funding support is measured by asking grantees to track two outcomes: Increased Stability and Improved Quality of Life.*
The data presented is self-reported and represents a wide diversity of organizational capacity and resources.

MMF recognizes that while the evaluative capacity of our funded partners are varied, the services measured were focused exclusively on those most vulnerable. The majority of these grant periods took place during the COVID-19 pandemic, which necessitated major changes to services offered, delivery method, and evaluation.





*MMF received a one-time bequest in FY2020 in the amount of \$367,561, of which \$187,811 went towards unique services for older adults and \$179,750 was used for immediate needs for older adults in the pandemic.





Immigrants & Refugees



The Immigrants and Refugees focus area seeks to help immigrants and refugees become fully productive members of our society while promoting their dignity.


Programs funded include but are not limited to interpretation services, legal assistance, housing and employment services, social justice advocacy, and training for fellow providers.




Overall Impact

Total Individuals Served: 519

The Veterans focus area supports services for veterans and their families that are not otherwise available through public organizations such as the Veterans Administration. Funding priority is given to programs serving veterans returning from post-9/11 conflicts.

Support is centered on the transition from military to civilian life through programs that address mental health needs, provide a sense of purpose and connection, support the whole family, and legal services.



Human Trafficking Prevention

66 A few days after the training, that parent called the volunteer coordinator. She said she had been processing the training...When she brought this up to her daughter, she disclosed she had been communicating with a boy online from Australia. She stated that she does not know if her daughter was just distracted or if it was a grooming situation, but because of our training, she was able to identify an issue and discuss it with her daughter before there were serious consequences.

The Human Trafficking Prevention focus area seeks to prevent and respond to all forms of human trafficking and exploitation through advocacy, public policy, education, direct services and outreach strategies.

Key to this work are programs that address the systemic risk factors of sex trafficking as an important part of the prevention ecology such as poverty, racism, homelessness.





Increased Awareness and Advocacy for Social Change





Overview

MMF believes that nonprofits are critical community catalysts for change, and that the stronger, healthier, and better prepared the nonprofit, the more effective they are at achieving that change.

MMF's Capacity Building Grant (CBG) funds provide grantee organizations with continuous learning opportunities to facilitate effective management, sound governance and increased organizational capacity.

Standard Capacity Building Grant Program

These grants help nonprofits make long-term improvements in their management, governance, or organizational capacity. Standard CBG funds generally support

consulting, training fees, information technology, and other costs directly related to activities and tools that help individuals and organizations perform with greater efficacy.

Comprehensive Organizational Assessment & Report (COAR)

COAR is a short-term capacity building project designed to provide a systematic analysis of the current state of the organization in its key capacity areas. From the assessment process and resulting report, the agency will gain insight into the organizational functional areas in which it is strong and those areas which

inhibit its effectiveness in accomplishing its mission. Guided by an MMF consultant, the assessment takes an in-depth look at where the agency stands in its organizational life cycle to inform how improvements can be made in its management and governance practices to sustain and grow its work in the future.

Grant Impact

In FY2021, MMF engaged The Rome Group to conduct an in-depth assessment of its Capacity Building, COAR, and Multi-Year grants, totaling nearly \$900,000 since 2014. Below are some quotes from leaders of funded organizations.

- "Some of that money is funding deficits that we have sustained during the pandemic, the capacity building work we did gave us an organizational safety net. It allows us to continue services in critical areas, free of charge, when we otherwise wouldn't have been able to."
- "Our programs were more focused and having a more significant impact on our clients, and we could prove it."
- "It enabled us to increase the number of people we serve by 40%".
- "We now have 100% board giving and greater engagement."
- "Board development and deployment (role clarity) and role delineation between the board and ED."
